













> Preface

Unnat Bharat Abhiyan (UBA) is flagship programme of the Ministry of Education (formally MHRD) that aims to enrich Rural India. ❖ Major problems identified in Vidarbha Region

- Inadequate availability of water resources and lack of use of modern irrigation technology
- Insufficient Agro based processing units as well as market facilities at local level
- Lack of skilled based trained personal in villages for optimal use of natural resources
- Lack of literacy & awareness about nutritional needs in some places of the Vidarbha region viz. Melghat, Gadchiroli are facing the problem of health, hygiene and malnutrition.
- Inadequate availability of industrial sectors viz. IT sectors & other employment producing sectors, the skilled youths migrates from the Vidarbha region.

❖ Suggestions & Expected Outcomes of UBA Mission

- To provide skill based training and encourage the youths of villages for technological intervention to start their small scale industries/ business which is based on locally available natural resources for strengthening the concept of Atmnirbhar Bharat.
- To formulate the strategies to reduce the loss of agricultural post harvest produce.
- To enhance the research of academic and research institutions towards resolving the local basic needs and associated problems.
- To provide training and awareness on sustainable use of natural resources and cost-effective alternative solutions.
- To frame the villages development planning based on problems identified by scientific communities along with appropriate solution.
- To establish the cluster/network at the local level with help of National Level Institutes, NGOs & Companies for enhancing need base research, technology and business plan/concepts.
- Government need to relase the directives to Grampanchyat and other related government offices to make them madetory to involved the Participating Institutes (PI) working under Unnat Bharat Abhiyan in Gram Panchayat Village Development Plan for making the system more accountable and provide the innovative, scientific, coste effective and need base solution for sustainable growth of villages.
- A designated officer and/or cell at the local government bodies level *viz*. District Collector, Zilha Parishad & Gram Panchayats for the effective implementation of the UBA mission is required for linking up the all government schemes related to rural development for effective implementation of Unnat bharat abhiyan.
- The UBA mission should be compulsorily included in the curriculum not only in higher education but school level also. Most of the school students from rural areas are belonging to farming families, if the said mission is implemented the school level it will result in better outcomes.
